

FORWARD

This volume, the eighth in the series, Toronto Studies in Central and Inner Asia, contains papers delivered at the 11th annual conference of the Central and Inner Asia Seminar (CIAS) which was held on 12-15 May 2005 at the University of Toronto.

The volume focuses on trade as an important economic mode of the Central and Inner Asian societies, and above all, as a way of interaction with the surrounding sedentary societies and cultures: China, India, the Middle East, Russia and many others, in ancient history, in colonial modernity, and today. The volume revisits the theme of ancient Silk Road and explores other less well-known trade routes. Seeing trade not just as economic transactions by barter or cash, but an essential system central to the way of life in the region having repercussion on the wider world, the papers deal with the role trade and traders played in religious conversion, diplomacy, power maintenance, colonial domination, market development, urbanization, education and so on in Central and Inner Asia. The papers also explore new opportunities and obstacles to trade in light of the profound economic and political transformations in the region.
